ELIGIBILITY REQUEST FORM (ERF)





This form is to be completed by all athletes that are not members of the parish sponsoring the team or not enrolled in the school sponsoring the team and those athletes that are only eligible for CYO participation through PSR enrollment. The completed form is to be submitted by the member athletic director to the CYO Office by the published deadline. Section 3-1-5 & 3-2 of the Bylaws of the Diocese of Cleveland CYO contains the policies for use of this document.

To Submit an ERF, the following processes should be used;

- 1. The parent of the athlete visits the CYO website to review the Listing of CYO Members.
- 2. The parent of the athlete visits the <u>Parish Locator</u> on the CYO website to identify the closest CYO Members to their residence or the member/parish address as noted on line 6 of the form.
- 3. If the CYO member (sponsoring member) that the parents wish their child to play for is not the "nearest" member to sponsor a team, contact must be made with the athletic director of those nearer CYO members to inquire about playing for their team, or to secure the approval by the athletic director authorizing permission to play at the next nearest CYO member.
- 4. If upon completion of review of the <u>Parish Locator</u>, the sponsoring member is not with-in the three (3) nearest members to the athlete's residence/parish/school to sponsor a team, the child is not eligible to play for that team and that they need to pursue participation at the other CYO Members within the nearest three (3) or contact the CYO Office as stated in bylaw 3-1-5.
- 5. The parent of the athlete secures completion of Section 1 of the Eligibility Request Form. The parent of the athlete secures the signatures in Section 1.
 - If your parish/school does not sponsor any CYO sports, then the signature of the Pastor/Principal is only needed on the form.
 - If your parish/school sponsors CYO in any sports, then the signature of the member athletic director is needed on the form. The athletic director will inform you know if the Pastor/Principal needs to sign the form as well.
- 6. Once Section 1 is complete, the parent is to communicate with the athletic director of the sponsoring member for verification of the <u>Parish Locator</u> and instructions on the process for contacting the athletic director of those nearer CYO members to inquire about playing for their team, or to secure the approval by the athletic director authorizing permission to play at the next nearest CYO member.
- 7. If upon verification of the <u>Parish Locator</u>, the sponsoring member is not with-in the three (3) nearest members to the athlete's residence to sponsor a team, the parent is to be told that they are not eligible to play for their team and that they need to pursue participation at the other CYO Members or contact the CYO Office as stated in bylaw 3-1-5.
- 8. Once Section 2 is complete, the athletic director of the sponsoring member can complete Section 3 of the ERF and submit the completed Eligibility Request Form, as well as supporting documents and approvals obtained through bylaw 3-2-3 to the CYO Office for review.

Submission restrictions for the Eligibility Request Form;

- 1. All eligibility request forms are to be submitted to the CYO Office by the athletic director of the sponsoring member for each athlete that may be eligible under bylaw 3-1-5 or bylaw 3-2.
- 2. The Eligibility Request Forms are to be submitted to the CYO Athletic Director by the regular team entry deadline.
- 3. The Eligibility Request Form cannot be approved by the CYO Athletic Administration prior to the regular team registration deadline.
- 4. An individual seeking eligibility through the ERF process is not permitted to be rostered on the team, participate in any practice, scrimmages or competitions for the sponsoring team until written approval is received from the CYO Administration.
- 5. Incomplete Eligibility Request Forms will be denied and the athlete will be ineligible until the form is submitted in its entirety and approved.
- 6. Eligibility Request Forms will not be accepted after the published start of season date.

Submissions for those that are members of parishes/schools that do not offer CYO sports;

Athletes that are members of parishes/schools that do not offer any sports programs may complete an Eligibility Request Form once per year for all sports for an athlete wishing to participate provided:

- 1. According to the findings of the <u>Parish Locator</u>, the sponsoring member is the nearest member to the athlete's residence to sponsor a team.
- 2. The completed form, listing all sports for participation, is submitted to the CYO Office by the published team entry date of the first sport the athlete is applying for.
- 3. All deadlines, processes and athlete participation limitations apply as outlined in bylaw 3-2-1.
- 4. The form will be valid for one (1) athletic year.
